
Russia is weighing restrictions on diesel exports after a wave of Ukrainian drone strikes on its refineries. Russia's seaborne crude exports climbed to a 16-month high in the past four weeks, a period in which the nation's own oil refineries have been forced to scale back production because of Ukrainian drone attacks. A Canadian First Nations development organization is recruiting 31 indigenous groups to propose a new oil pipeline from Alberta to the northern British Columbia coast, a project supported by Alberta's Premier Danielle Smith and Prime Minister Mark Carney. Oil producers Exxon Mobil Corp., Petrobras and contractor TechnipFMC Plc have petitioned Brazil's antitrust watchdog to oppose a merger between Italy's Saipem SpA and Norway's Subsea 7. The API reported US crude inventories fell 3.8 million barrels last week, according to a document seen by Bloomberg.




