As Ukraine and its allies absorbed the surprise from Donald Trump's newly upbeat view of Kyiv's prospects in its war against Russia's invasion, there were signs of a familiar move by the US president — upping the pressure on Europe, not Russia. Two key oil ports on Russia's Black Sea coast halted loading of tankers after overnight warnings of drone attacks, the latest sign of how Ukraine is disrupting its foes energy infrastructure. Traders are betting on a surging diesel market as an escalation in Ukrainian attacks on Russian fuelmakers threatens to tighten global supply. The US oil and gas industry is taking its private backlash against President Donald Trump's energy agenda to the next level, warning that policy missteps are hurting the world's biggest oil producer. TotalEnergies SE said it will buy back fewer shares in the fourth quarter and into next year as it contends with mounting debts and a challenging oil-market outlook.




