Two months after sanctions plunged Indian refiner Nayara Energy Ltd. into crisis, upending trade and forcing the abrupt exit of its European executives, the company's operations and sales are recovering, thanks to government support and workarounds. Terminal operators at China's Qingdao Port will ban tankers that are 31-years or older from berthing, along with ships that altered their identities or have invalid certifications, according to a notice dated Sept. 18. Occidental Petroleum Corp. is in talks to sell its OxyChem petrochemical unit in a deal worth at least \$10 billion, the Financial Times reported. Asian refiners have purchased more US crude for arrival in late December to January at a ~\$4-\$4.50/bbl premium to the Dubai benchmark, according to traders familiar with the matter. TotalEnergies SE is under mounting pressure to show it can sustain payouts and deliver returns from its push into low-carbon energy as debt climbs and shares lag behind peers.






