Lithium Hydroxide Commentary

On the first trading day after China's National Day holiday, **CME lithium hydroxide** and **lithium carbonate** trading activity rebounded, with notable transactions in **Q1'26**.**GFEX lithium carbonate** prices edged up, with the **main contract rising 0.82%** and **SMM lithium carbonate** increasing by **7 yuan/ton**. The **spot-futures spread** shifted back to a **discount**, around **-50 yuan/ton**. The **CME lithium hydroxide** average transaction price continued to fluctuate within its recent range.

CME cobalt metal trading remained active, with most deals concentrated in Q1'26 and Q1'27. The Wuxi cobalt market continued to rise, up by 7–7.5 RMB/kg (approximately \$0.45–0.48/lb). Similarly, the CME cobalt metal average transaction price increased by \$0.25–0.30.
