India's oil imports from Russia dipped in September, but held at about a third of overall shipments in spite of a US push to curb flows. Russia banned diesel exports for some companies and extended restrictions for gasoline sales abroad as Ukrainian drone strikes disrupt nation's refinery runs. Exxon Mobil Corp. plans to cut about 2,000 jobs globally as the Texas oil company consolidates smaller offices into regional hubs as part of its long-term restructuring plan. Imperial Oil Ltd, which on Monday announced plans to cut 20% of its workforce, will be selling its headquarters in Calgary as part of the restructuring. The head of Glencore Plc's oil and gas trading team is planning to leave the company, becoming the latest high profile departure from one of the world's biggest commodity traders. Global oil demand continues to expand at a rate that justifies the supply increases coming out of OPEC+, according to the chief executive officer of Kuwait Petroleum Corp. COMING TODAY






