Ukraine's forces struck a crude oil processing unit at a Bashneft refinery in Ufa, Bashkortostan, with drones early Saturday, according to a person familiar with the matter. Oil-tanker rates spiked the most in years and some vessel bookings faced cancellations as trade tensions between the world's two largest economies escalated afresh. Russian President Vladimir Putin relaxed the rules on fuel subsidies to the nation's refiners, allowing them to continue receiving billions of rubles in aid amid intensified Ukrainian attacks on the industry. A VLCC en route to China's Rizhao port has made a u-turn after the US sanctioned Sinopec-linked Rizhao Shihua Crude Oil Terminal Co. on Friday, as part of a broader effort to choke off Iranian energy exports.






