A "long-anticipated global surplus has started to show" in the oil market, according to Goldman Sachs Group Inc.

The US Senate will hold off on considering new sanctions legislation on Russia until after President Donald Trump's planned meeting with Russian President Vladimir Putin. President Donald Trump said on Monday that the US would destroy Hamas if the militant group didn't continue to honor the ceasefire with Israel, with a fragile truce resuming after a weekend of heavy fighting in the Gaza Strip. Brazil's state-controlled energy company received approval to explore for oil near the mouth of the Amazon River, capping a years long standoff with environmental regulators. China's apparent crude supplies topped demand by 533k b/d in September, down 45% on-month and 40% on-year.


