Saudi Aramco may reduce the official selling price of Arab Light crude by \$1.25/bbl for sales to Asia in December, according to the median estimate in a Bloomberg survey of eight traders and refiners. Kazakhstan is in talks with Exxon Mobil Corp. about tapping the undeveloped part of the giant Kashagan oil field, said people familiar the matter. Canadian oil producer MEG Energy Corp. postponed a shareholder vote on a C\$7.6 billion (\$5.4 billion) takeover proposal by Cenovus Energy Inc. until next week to give it time to disclose more information on asset sales. Russian oil producer Lukoil PJSC has agreed to sell its international assets to energy trader Gunvor Group, a week after being hit by US sanctions.




