The London afternoon session opened at \$102.20, which was also the high of the session. Flat price then fell to a low of \$101.95 before closing at \$101.75. Little activity was seen across both outright and spreads, with prompt months trading in smalls in a range of 10–25kt. Spreads remained unchanged, with Dec/Jan trading at \$3.10 in 42.5kt.

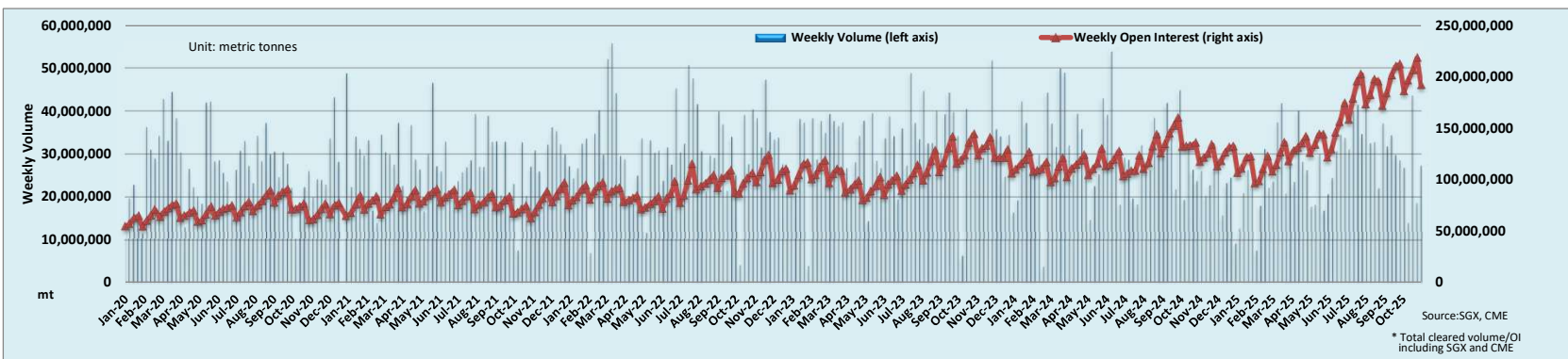
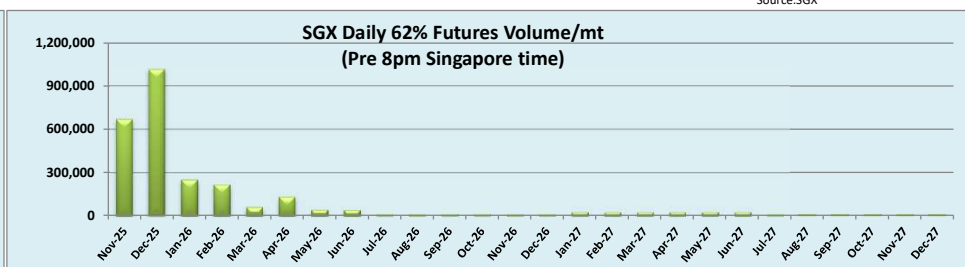
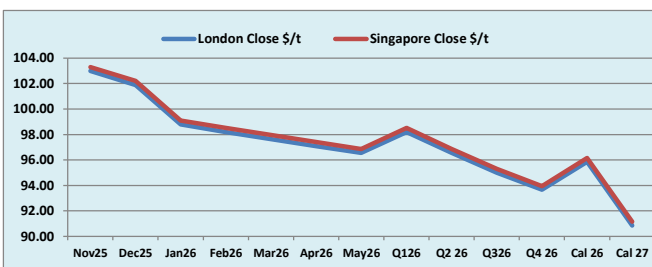
