The London afternoon session opened at \$102.70, which was also the high of the session. The flat price then steadily fell to a low and close of \$102.00. Little activity was seen in outright during the session, with prompt months trading in smalls. Spreads remained unchanged during the session, with Dec/Jan seeing a pay at \$3.15 trading in two 50kt clips, while Dec/Feb saw a sell, trading in size at \$3.70 in 200kt.

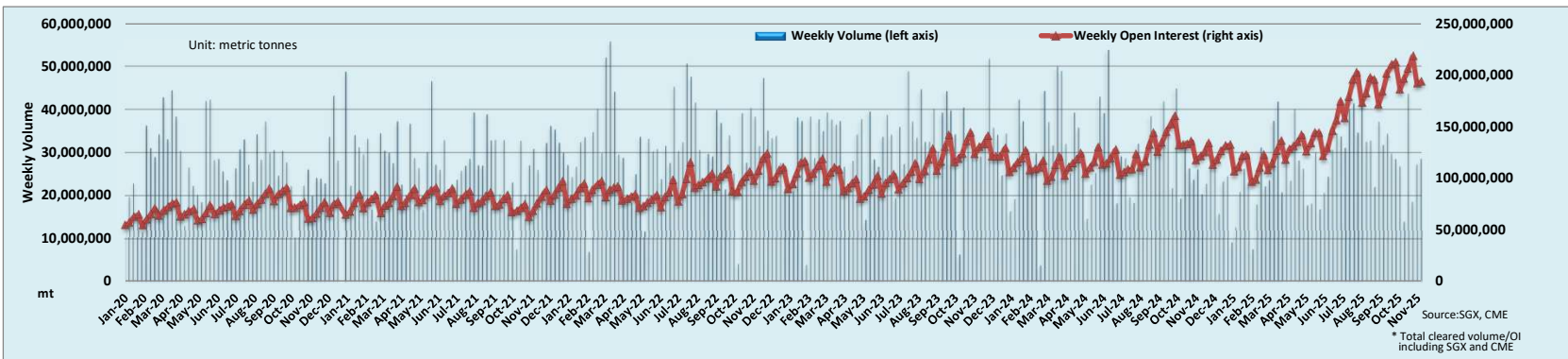
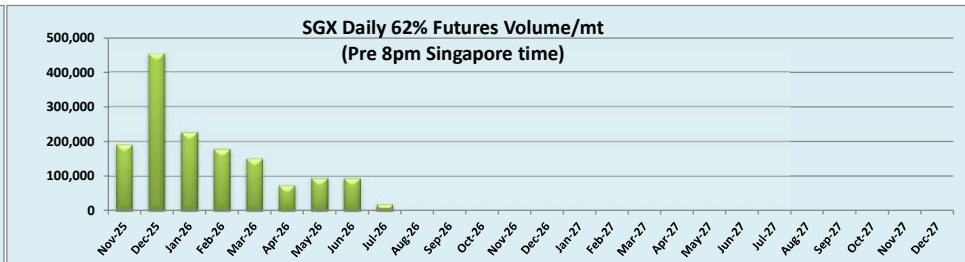
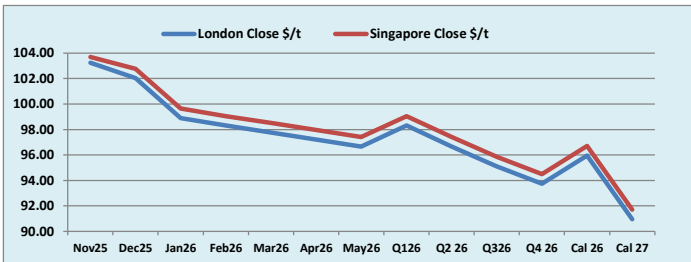
