### **Market Commentary / Recent Trades**

The Singapore morning session opened at \$102.10, prices fell to a low of \$101.95 before climbing to a high of \$102.95 and closing near the highs at \$102.70. Little activity was seen in the morning session and spreads remained unchanged except for Nov/Dec as it traded \$1.00 in 50kt.

When the afternoon session resumed, Q1-26/Q2-26 widened from \$1.65 yesterday to \$1.70 today as front-month spreads widened. Q1-26/Q2-26 was seen trading \$1.70 in 30kt and \$1.75 in 70kt signalling strong pays. Jan/Q1-26 traded \$0.60 in 150x50kt and Nov/Dec continued to be traded \$1.00 in 500kt.

Mysteel reports that the Simandou project's commissioning is largely symbolic for now, as it will add less than 1 million tons of iron ore to global supply this year. However, production from both the northern and southern blocks is expected to rise to about 20 million tons by 2026.

### 市场评论 / 近期交易

新加坡今早开盘于102.10美元,价格先下跌至101.95美元的低点,随后回升至102.95美元的当日高点,最终收于102.70美元。早盘交易较少,除11月/12月外,其余价差保持不变。11月/12月在1.00美元交易5万吨。

午盘即期合约价差扩大,26年Q1/26年Q2由昨日的1.65美元扩大至今日的1.70美元。26年Q1/26年Q2在1.70美元交易3万吨,以及在1.75美元交易7万吨,交易积极。1月/26年Q1在0.60美元交易15x5万吨,11月/12月在1.00美元再次交易50万吨。

据我的钢铁网报道,西芒杜矿区的投产仪式目前仅具有象征意义,今年对全球铁矿石供应的新增量不足100万吨。但预计到2026年,南、北矿区的产量将分别上升,总产量约可达2000万吨。
