The London afternoon session opened at \$104.20, flat price then rose to a high of \$104.30 before falling to a low of \$104.05 and closed at \$104.25. Little activity was seen in the session, with flat-price prompt months trading in smalls except for two clips of Dec in 50kt. Spreads also saw muted trading as Dec/Mar traded at \$5.10 in a total of 68kt, while Dec/Feb continued to trade at \$4.35 in 30kt. In quarter spreads, Q1/Q2 traded at \$1.95 in smalls, tightening from yesterday's trading level at \$2.00.

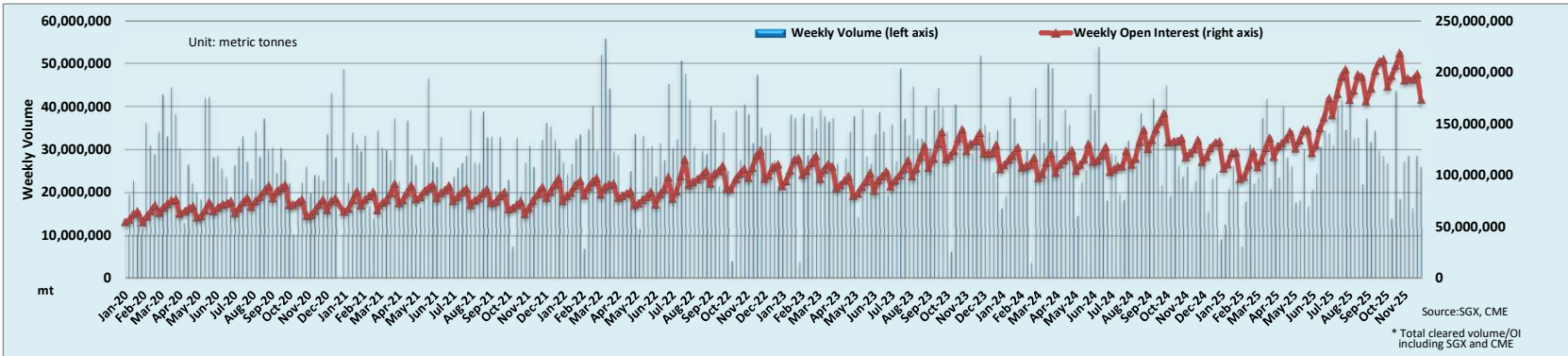
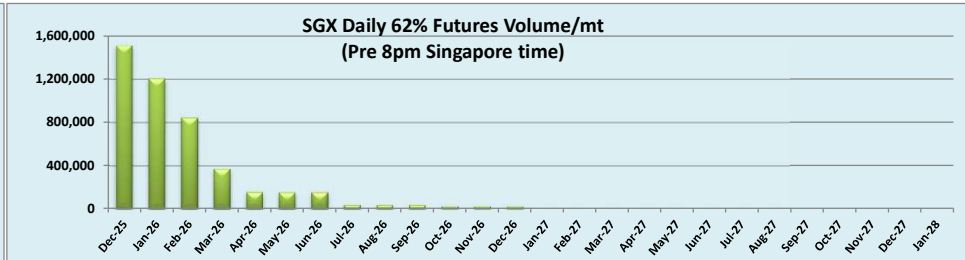
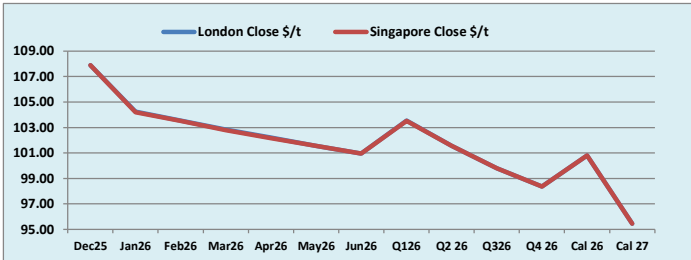
