### IN THE NEWS [Bloomberg]

US forces intercepted and seized a sanctioned oil tanker off the coast of Venezuela, marking a serious escalation of tensions between the two countries. The massive tanker seized by US forces off Venezuela has been part of the dark fleet for a number of years and was already well known by American authorities for its role in the Iranian oil trade. Chevron's operations in Venezuela continue as normal. Ukraine carried out yet another attack on a shadow-fleet tanker linked to Russia's oil trade as it continues to target Moscow's vital seaborne petroleum trade. Canadian crude weakened in Alberta and the US Gulf as rival producers in the Middle East cut their official prices.




