Russia's seaborne crude shipments fell for a third week, sliding to a two-month low, with declining volumes compounding lower prices to hit the Kremlin's war funds. Governments across Europe and the Middle East are rushing to ensure the sprawling oil operations of Russian energy giant Lukoil PJSC can keep running after the US Treasury sanctioned the company and then quashed a key bid for its assets last week. Key North Sea crude market indicators slid to the lowest in more than a year, indicating a darkening outlook for prices in the coming months as supplies continue to grow. India has scaled back purchases of Russian crude for arrival in December, showing that Western sanctions and trade talks with the US are having a major impact on buying patterns.






