Crude oil will be burdened by a surplus, while gold is set to extend gains to a fresh record next year, according to Goldman Sachs Group Inc. For months, legal experts and members of Congress have questioned the legality of President Donald Trump's military campaign against alleged narco-terrorists off Venezuela and Colombia. A new blockade on oil tankers compounded those concerns. The UK sanctioned oil trading tycoon Murtaza Lakhani, part of a new package targeting Russia over its war against Ukraine. The North Sea Buzzard oil field has completed planned maintenance and is set to restart soon, people with knowledge of the matter said.
