



# London Iron Ore Market Report

The London afternoon session opened at \$108.15, flat price then rose to a high of \$108.25 before falling to a low of \$107.75 and closing at \$108.10. Trading in this session was muted with most activity coming in prompt month outright trading in smalls. Jan/Feb fluctuated in levels relative to flat price movement but traded at -\$0.05 in a total of 200kt, while Feb/Mar also became better bid from earlier in the day, trading at \$0.35 in 50kt. Quarter spreads were also widened a touch, marking the Q2/Q3 at \$1.45 compared to \$1.40 where it was trading earlier in the day.

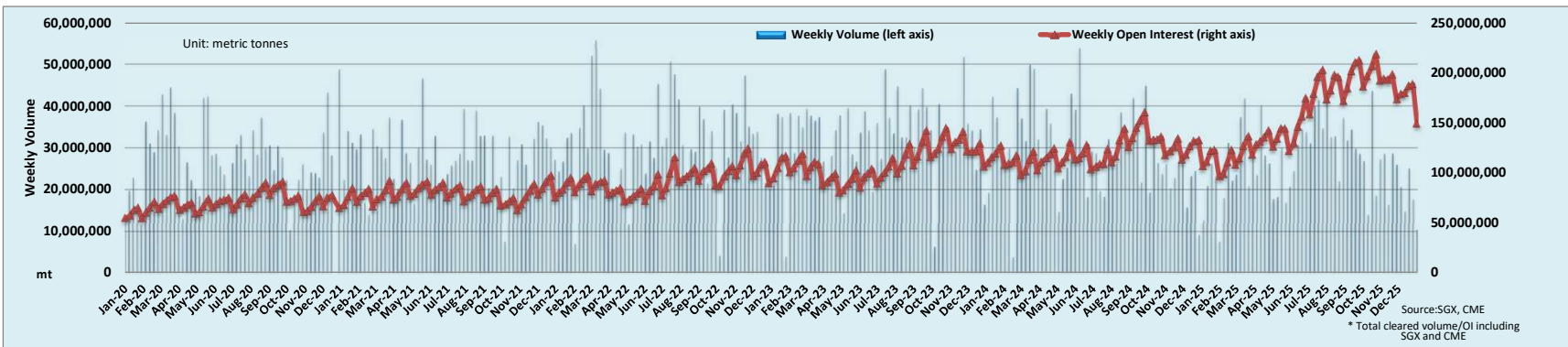
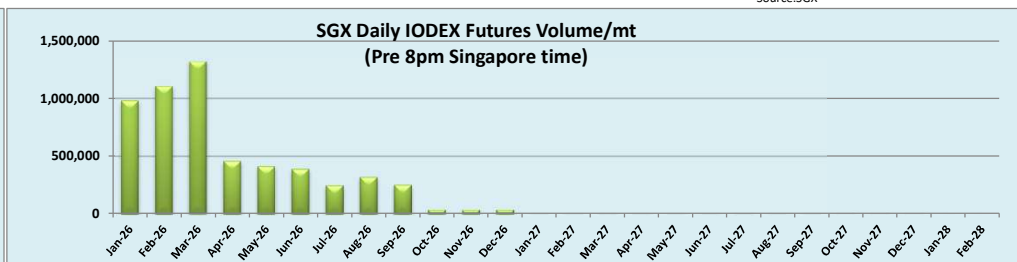
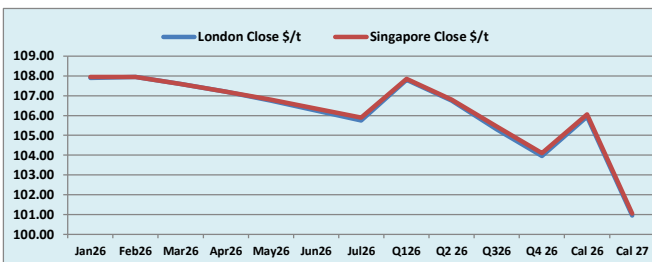
