The London afternoon saw flat price drop off more than a dollar as we closed at Feb \$108.20.

The fall-off in the prompt month contributed to Jan/Mar trading at par in 100kt. Elsewhere, we saw selling interest in the quarter outright. Most volume was concentrated on Q3 selling, but there was also decent sized trading in Q2 and Q4. Spreads were largely unchanged outside of Jan/xxx, with Feb/Mar closing at \$0.25.

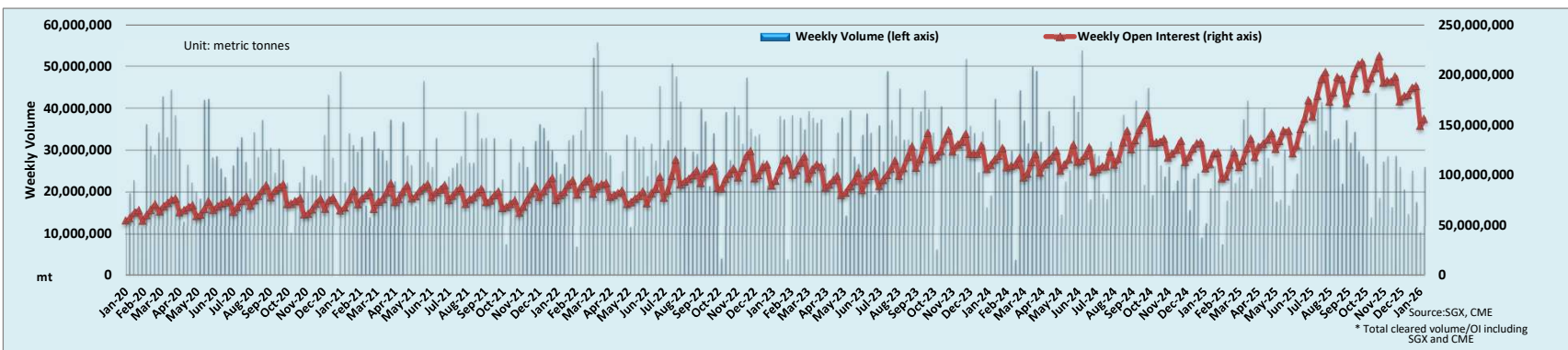
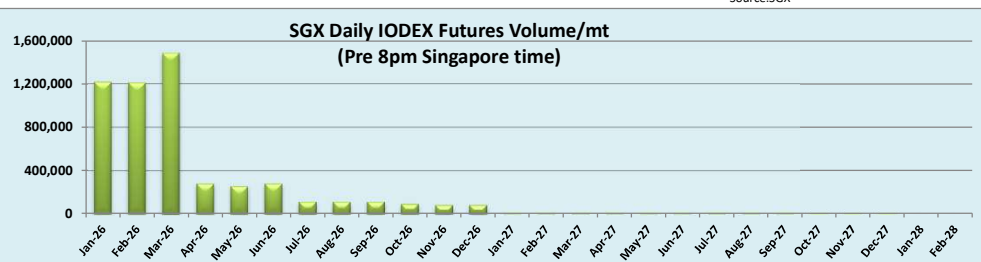
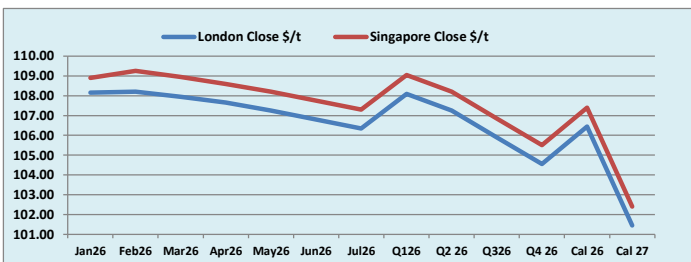
