


IN THE NEWS [Bloomberg]

President Trump signalled he's leaning toward excluding Exxon Mobil Corp. from his push for US oil majors to rebuild Venezuela's petroleum industry, saying he was displeased with the company's response to his initiative. Guyana, home to the world's biggest oil discovery in decades, appears to be an early beneficiary of President Trump's ouster of Venezuelan strongman Nicolas Maduro. The US special forces raid that captured Nicolas Maduro in Caracas was executed smoothly after months of planning. What comes next in Venezuela is likely to be much messier and more protracted — undercutting hopes of a quick, oil-fueled economic recovery. Ukraine overnight targeted three drilling platforms in the Caspian Sea owned by Russian oil major Lukoil PJSC in the latest move to weaken Russia's economic capacity to fund its war effort.


