The Trump administration issued a general license expanding the ability of oil companies to operate in Venezuela. OPEC+ remains on track to ratify the last part of this quarter's oil production pause, delegates said. The Alberta government is looking at a proposal to ship oil by railcars to Canada's east coast and then to Europe. Valero Energy Corp. is in talks with sellers to purchase more Venezuelan crude as sanctioned oil flows out of the country.


