Mar reached a high of \$18,300 and april reached a high of \$18,750. Further out, Cal27 traded at both \$14,400 and \$14,450.

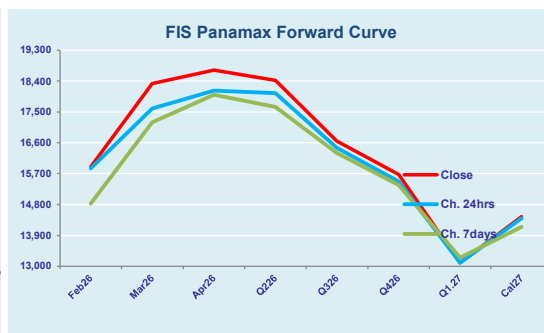
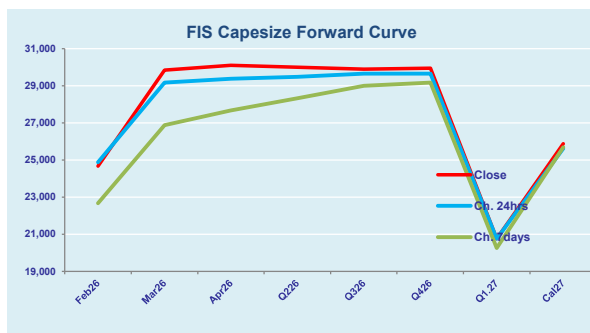
