

The London afternoon session opened at \$102.75, with flat price then rising to a high of \$103.05 before falling to a low of \$102.60 and closing at \$102.75. Little activity was seen in this session across both outright and spreads, with most activity coming in prompt months trading in smalls. Spreads remained unchanged during the session; Feb/Mar saw a pay trading at \$0.10 in 50kt, whilst further down the curve, similar to yesterday's T+1 session, 1H-27/2H-27 traded again at \$1.85, but only in 2kt.
