Muted activity was seen in the session across both outright and spreads, with most activity coming in prompt-month outright trading in smalls ranging between 10–20kt clips.

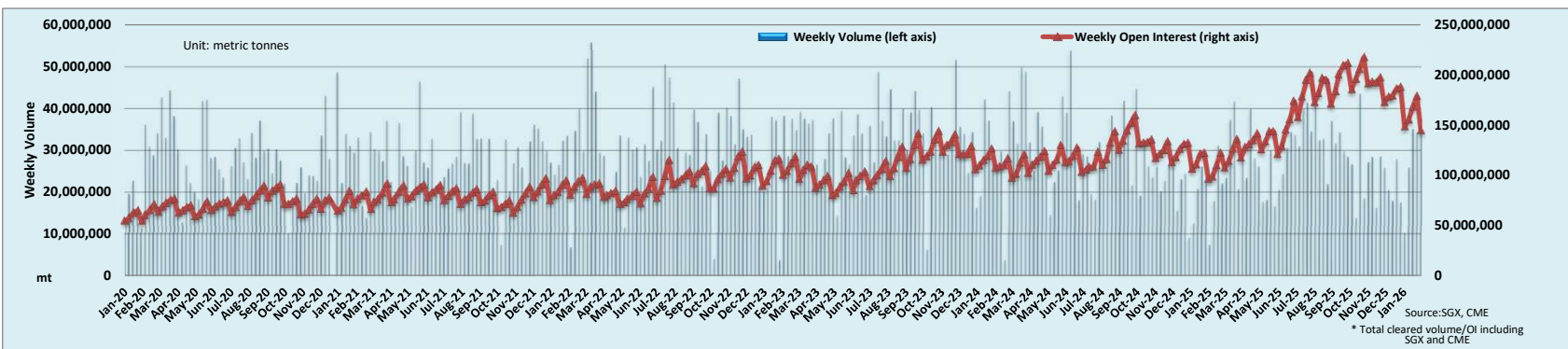
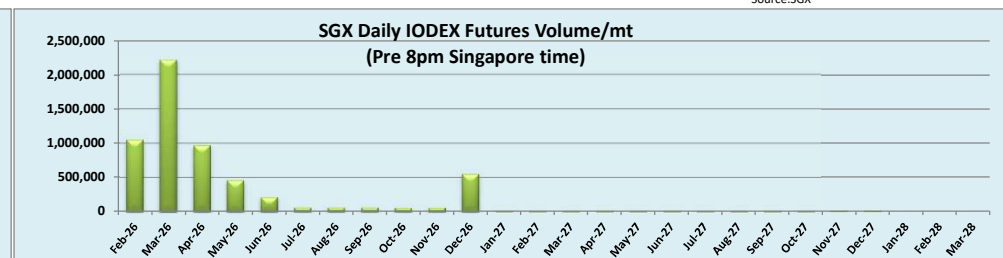
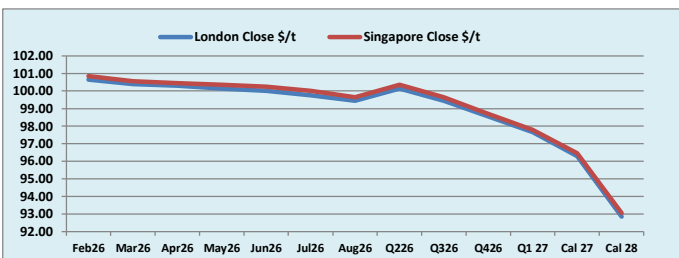
