The London afternoon session opened at \$101.60, which was also the low of the session. Flat price then climbed to a high and close of \$102.20. Little activity was seen across the session in outright, with prompt months trading in smalls. Spreads remained unchanged during the session, with liquidity coming in quarter spreads where Q2/Q3 traded at \$1.35 in a total of 25kt, while Q4/Q1 also traded in a total of 60kt at \$1.10.




