The London afternoon session opened at \$108.20. Flat price then rose to a high of \$108.35 before falling to a low and close of \$107.85. Little activity was seen in the session across outright, with prompt months trading in smalls except for a 70kt clip of Apr. Regarding spreads, they tightened a touch, with liquidity being seen in Q2/Q3 trading at \$2.20 in multiple clips totalling 100kt. Further down the curve, June/Cal27 saw strong pay, trading at \$6.00 in 30x2.5kt, whilst in prompt months May/Aug traded at \$2.20 in 50kt.




