The London afternoon session opened at \$106.80, which was also the low of the session. Flat price then rose to a high of \$107.85 before coming off and closing at \$107.30. Sizable clips were seen trading across outright, with Apr, May, and June all trading in clips of 100+75kt. Spreads remained relatively unchanged during the session. May/June saw the most activity, trading at \$0.90 in 100+50kt. Apr/May also traded at \$1.1 in 39.6kt, whilst further down the curve June/Q3 traded at \$1.25 in 60x20kt.




