**Verdict-Our View is Neutral to Bullish.**

As expected, DCE May26 has returned to its upward channel after breaking through the intraday resistance at 792.0. On the hourly chart, the slow stochastic KD has crossed bearishly, the CCI remains in bullish territory, and the MACD is flat near the zero line. New long positions have entered the market over the past two trading sessions, suggesting the rally may sustain, but external shocks from highly volatile commodities such as crude oil should be watched closely.
