

Market Commentary / Recent Trades

The Singapore morning session opened at \$107.65, fell to a low of \$107.40, then climbed to a high of \$108.45 before closing near the highs at \$108.40. May/Q3-26 continued to be seen since yesterday as it traded \$2.30 in 375x125kt, and Apr/Q3-26 traded \$3.40 in 300x100kt. Spreads generally remained unchanged. In addition, Apr/July traded at \$2.75 in 150kt.

Little activity was seen in the afternoon session; prompt months traded in smalls whilst spreads remained unchanged. However, flat price did come off before rising again due to the news below.

The Donald Trump administration is considering military action targeting Kharg Island to pressure Iran into reopening the Strait of Hormuz. The plan could involve a takeover or blockade but would likely only happen after further weakening Iran's military in the region. The U.S. is also preparing by deploying additional troops, signaling a potential escalation in the conflict..



市场评论 / 近期交易

新加坡今早开盘于107.65美元，下跌至107.40美元低点，随后上涨至108.45美元高点，并在接近高位的108.40美元收盘。5月/26年Q3延续昨日活跃，在2.30美元交易37.5x12.5万吨，4月/26年Q3在3.40美元交易30.0x10.0万吨。整体价差基本保持不变。此外，4月/7月在2.75美元交易15万吨。

午盘成交清淡，即期合约有少量交易，价差整体维持不变。不过4月合约在消息影响下先回落后反弹。

消息面上，美国特朗普政府正考虑针对哈尔格岛采取军事行动，以施压伊朗重新开放霍尔木兹海峡。该计划可能包括接管或封锁，但更可能在进一步削弱伊朗在该地区的军事力量后实施。美国同时正通过增派部队进行准备，显示冲突可能进一步升级。
