

Market Commentary / Recent Trades

The Singapore morning session opened at \$106.65, fell to a low of \$106.55, then climbed to a high of \$107.50 before closing at \$107.20. Interest further down the curve was spotted as Q2-26/H1-27 traded \$5.45 in 10x5kt. Apr spreads remained active as Apr/Q3-26 traded \$3.15 in 60x20kt and Apr/Jun traded \$1.85 in 60kt total. May/Jun also traded \$0.95 in 300kt. Apr/Q3-26 then narrowed to \$3.10 in 270x90kt. Quarter outrights remained active as Q2-26 traded in the range of \$106.00 - \$106.45 in 74kt total, Q3-26 traded in the range of \$104.10 - \$104.15 in 29kt total, and Q4-26 traded in the range of \$102.40 - \$102.45 in 39kt total. Front-month spreads were seen widening.

When the afternoon session resumed, trading remained muted. Apr/Jun traded again at \$1.85 in 250kt total. Spreads were then seen narrowing. After DCE closed, Apr/May traded \$0.90 in 300kt, and Q2-26/Q4-26 traded \$3.85 in 50kt. Mar/Apr remained active late in the month, trading at \$-1.00 in 50kt. Apr/Q3-26 was spotted trading again at \$3.15 in 30x10kt.

Severe Tropical Cyclone Narelle is disrupting operations along Australia's west coast, causing mine closures and evacuations and posing risks to both gas and iron ore production. The cyclone is tracking near major LNG export facilities, generating strong winds that are expected to halt gas cargo loadings. As Narelle moves over warm waters, it could intensify to a Category 5 system, bringing heavy rainfall that threatens open-pit iron ore mines in the Pilbara region.



市场评论 / 近期交易

新加坡今早开盘于106.65美元，下跌至106.55美元的低点，随后上涨至107.50美元的高点，最终收于107.20美元。远期合约有一些交易兴趣，26年Q2/27年上半年在5.45美元交易1.0x0.5万吨。4月相关价差持续活跃，4月/26年Q3在3.15美元交易6.0x2.0万吨，4月/6月在1.85美元交易6万吨。5月/6月在0.95美元交易30万吨。随后4月/26年Q3收窄至3.10美元交易27.0x9.0万吨。季度合约同样活跃，26年Q2在106.00至106.45美元之间交易7.4万吨，26年Q3在104.10至104.15美元之间交易2.9万吨，26年Q4在102.40至102.45美元之间交易3.9万吨。即期价差整体呈扩大趋势。

午盘交易依然清淡。4月/6月再次在1.85美元交易25万吨，随后价差收窄。大商所收盘后，4月/5月在0.90美元交易30万吨，26年Q2/26年Q4在3.85美元交易5万吨。临近月末，3月/4月持续活跃，在负1.00美元交易5万吨。4月/26年Q3再次在3.15美元交易3.0x1.0万吨。

强热带气旋纳蕾勒正在扰乱澳大利亚西海岸的运营，导致矿山关闭和人员撤离，并对天然气及铁矿石生产构成风险。该气旋正在接近主要的液化天然气出口设施，强风预计将迫使天然气装船暂停。随着纳蕾勒在暖水区域移动，可能增强为五级气旋，并带来强降雨，对皮尔巴拉地区露天铁矿矿山构成威胁。
