

## Market Commentary / Recent Trades

The Singapore morning session opened at \$107.40, went to a high of \$107.50, then fell to a low of \$106.45 before closing near the lows at \$106.55. Little activity was seen in the morning session. Q2-26/Q3-26 remained active since yesterday as it traded \$2.15 in 20kt total. Apr outright also traded in the range of \$106.40 - \$107.10 in 25kt total, and May outright traded in the range of \$105.60 - \$105.95 in 75kt total. Front-month spreads were seen widening.

When the afternoon session resumed, trading remained muted. Q2-26/Q3-26 then traded again at \$2.15 in 15kt. Apr/May remained active as it traded at \$1.05 in 135kt total. After DCE closed, Apr/May widened again to \$1.10 in 200kt total.

Iron ore arrivals at 45 Chinese ports increased to 24.26 million tons, up 1.55 million tons from the previous week, while arrivals at the six major northern ports rose by 1.48 million tons to 11.98 million tons. China's Manufacturing PMI improved to 50.4% in March, up 1.4 percentage points m/m, indicating a return to expansion. The Production Index reached 51.4%, and the New Orders Index rose to 51.6%, gaining 1.8 and 3.0 percentage points respectively, reflecting stronger manufacturing activity and improved demand.



## 市场评论 / 近期交易

新加坡今早开盘于107.40美元，上涨至107.50美元的高点，随后下跌至106.45美元的最低点，最终收于106.55美元，接近当日低点。早盘整体交易清淡。26年Q2/26年Q3延续昨日活跃，在2.15美元交易2万吨。4月在106.40至107.10美元之间交易2.5万吨，5月在105.60至105.95美元之间交易7.5万吨。即期价差整体呈扩大趋势。

午盘交易依然清淡。26年Q2/26年Q3再次在2.15美元交易1.5万吨。4月/5月持续活跃，在1.05美元累计交易13.5万吨。大商所收盘后，4月/5月进一步扩大至1.10美元交易20万吨。

中国45个港口铁矿石到港量升至2426万吨，较上周增加155万吨，北方六大港口到港量增加148万吨至1198万吨。中国3月制造业采购经理人指数回升至50.4%，较上月上升1.4个百分点，重回扩张区间。其中生产指数为51.4%，新订单指数为51.6%，分别上升1.8和3.0个百分点，显示制造业活动增强、需求有所改善。
