The London afternoon session opened at \$105.90, which was also the high of the session. Flat price then fell to a low of \$105.40 and closed at \$105.75. Little activity was seen in the session across both outright and spreads. Outrights traded in smalls, with liquidity seen in prompt months. Spreads remained unchanged except for Apr/May, which fluctuated with flat price movement. June/Q4 saw a strong pay, trading at \$2.45 in 30x10kt.

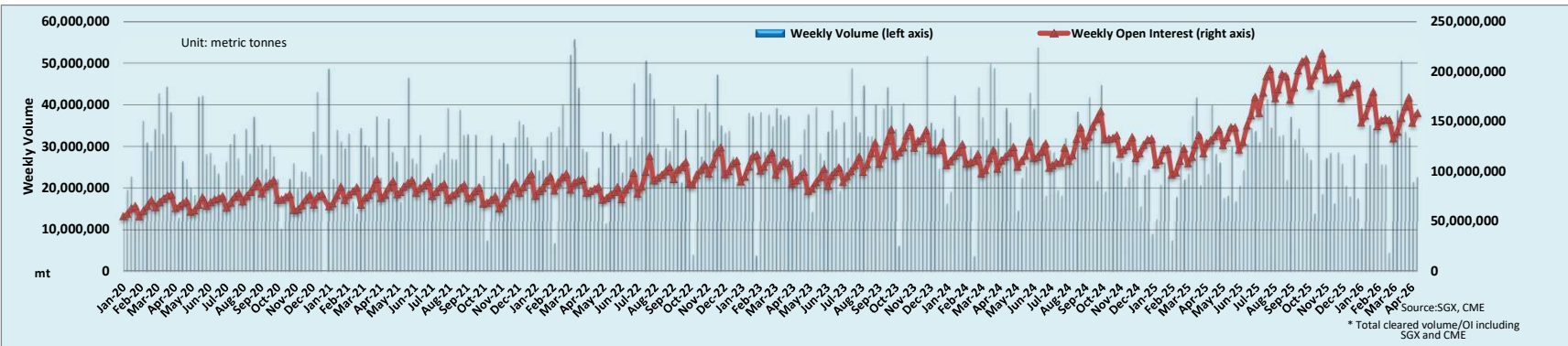
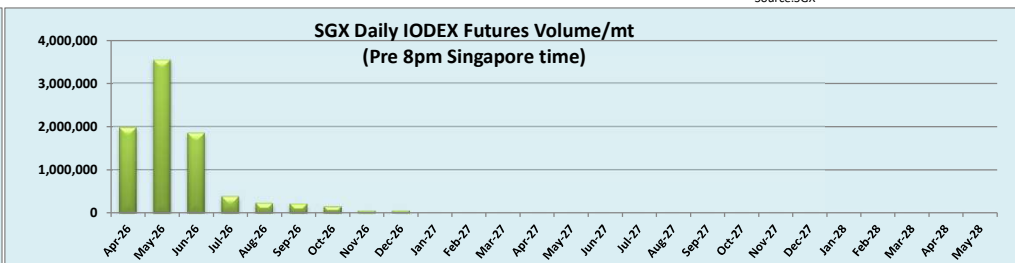
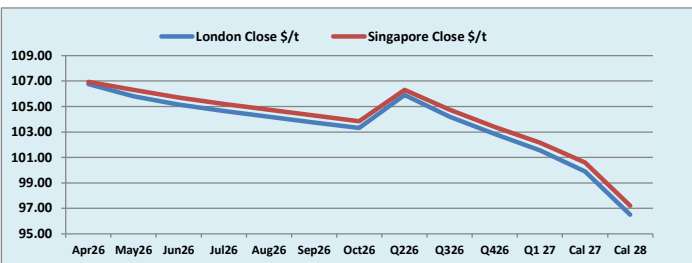
