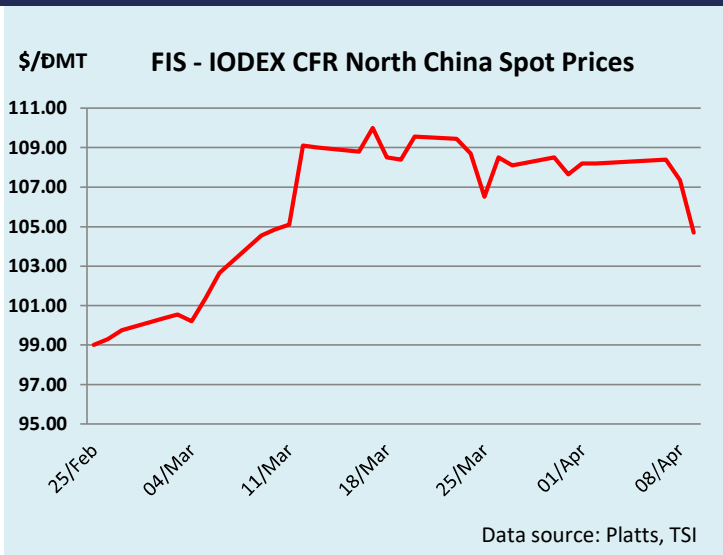

Market Commentary / Recent Trades

The Singapore morning session opened at \$104.75, went to a high of \$104.80, then fell to a low of \$103.60 before closing near the lows at \$103.70. Apr/May interests continued from yesterday and traded at \$1.85 in 50kt. May/Jun also traded at \$0.95 in 480kt total. Spreads were seen narrowing.

When the afternoon session resumed, May outright traded in the range of \$102.85 - \$103.05 in 225kt total. Apr/May remained active as well, trading at \$2.10 in 50kt and \$2.15 in 100kt total. May/Jun traded \$0.90 in 50kt before narrowing to \$0.85 in 100kt. Interest further down the curve was spotted as May/H1-27 traded \$6.00 in 24x4kt, Q3-26/Q4-26 traded \$1.65 in 10kt, and Dec/Feb traded \$0.90 in 20kt. After DCE closed, May/Jun continued to trade at \$0.85 in 200kt total.

During March 30 to April 5, total iron ore inventories at seven major ports in Australia and Brazil reached 14.887 million tonnes, rising by 2.15 million tonnes week on week. This increase signals a clear recovery in port stock levels, with inventories climbing to their highest point so far this year.

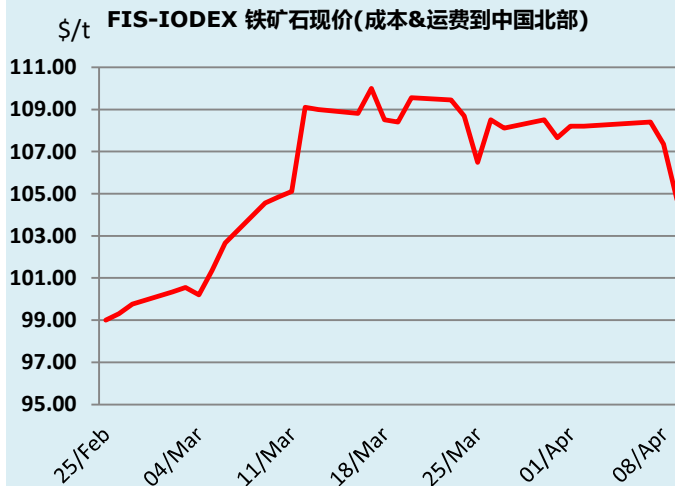

市场评论 / 近期交易

新加坡今早开盘于104.75美元，上涨至104.80美元的高点，随后下跌至103.60美元的低点，在103.70美元收盘，接近当日低点。4月/5月延续昨日交易，在1.85美元交易5万吨。5月/6月在0.95美元总计交易48万吨。价差整体呈收窄趋势。

午盘5月在102.85至103.05美元之间交易22.5万吨。4月/5月持续活跃，在2.10美元交易5万吨，并在2.15美元交易10万吨。5月/6月在0.90美元交易5万吨，随后收窄至0.85美元交易10万吨。远期合约也有一些交易量，5月/27年上半年在6.00美元交易2.4x0.4万吨，26年Q3/26年Q4在1.65美元交易1万吨，12月/2月在0.90美元交易2万吨。大商所收盘后，5月/6月在0.85美元再次交易20万吨。

3月30日至4月5日，澳大利亚与巴西七大港口铁矿石库存升至1488.7万吨，周增加215万吨，表明港口库存明显回升，并达到年内最高水平。
