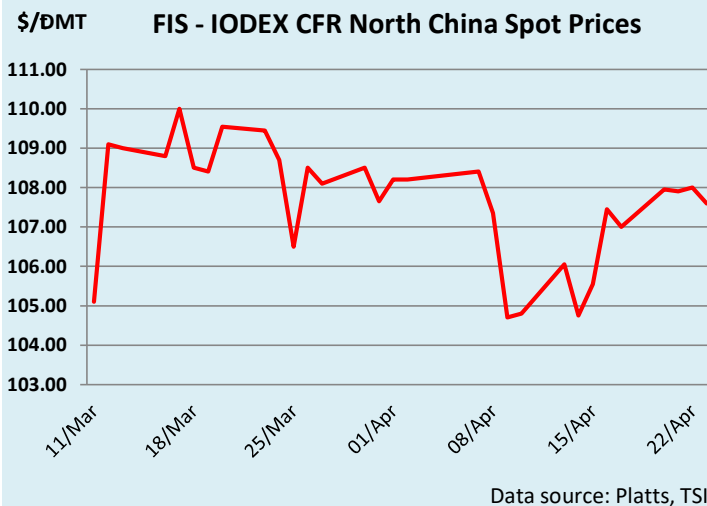

## Market Commentary / Recent Trades

The Singapore morning session opened at \$106.95, went to a high of \$107.15, then fell to a low of \$106.30 before closing at \$106.40. May/June remained active since yesterday as it traded in the range of \$0.525 - \$0.65 in 543kt total. May outright also traded in the range of \$107.00 - \$107.10 in 100kt total. Interest further down the curve was spotted as Cal-27/Cal-28 traded \$3.35 in 5kt. Spreads were seen narrowing.

When the afternoon session resumed, May/June traded again in the range of \$0.525 - \$0.575 in 500kt total. After DCE closed, May/July traded \$1.05 in 100kt, and Jun/Q3-26 traded again since last night at \$1.00 in 15x5kt.

Inventory levels at major Chinese steel mills rose by 5.8% to 17.5 million metric tons in early April compared with late March, according to the China Iron and Steel Association, with stocks standing 9.2% higher than the same period last year.

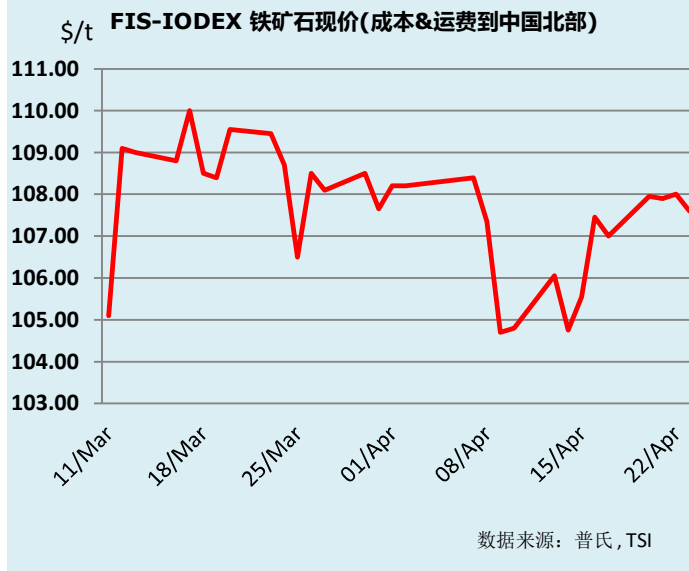

## 市场评论 / 近期交易

新加坡今早开盘于106.95美元，上涨至107.15美元的高点，随后下跌至106.30美元的最低点，最终收于106.40美元。5月/6月延续昨日活跃，在0.525至0.65美元之间总计交易54.3万吨。5月在107.00至107.10美元之间交易10万吨。远期合约也有一些交易兴趣，Cal27/Cal28在3.35美元交易5000吨。价差整体呈收窄趋势。

午盘5月/6月再次在0.525至0.575美元之间交易50万吨。大商所收盘后，5月/7月在1.05美元交易10万吨，6月/26年Q3的交易兴趣延续至今日，在1.00美元交易1.5x0.5万吨。

根据中国钢铁工业协会数据，4月上旬中国主要钢厂库存较3月下旬上升5.8%至1750万吨，较去年同期上升9.2%。
