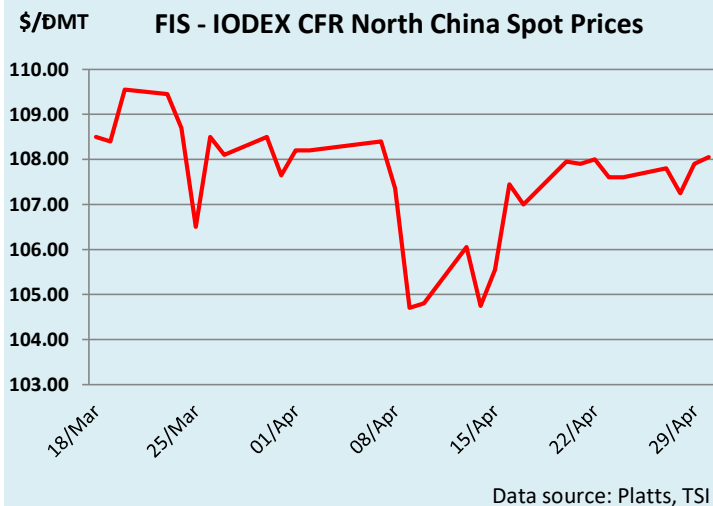

Market Commentary / Recent Trades

The Singapore morning session opened at \$106.90, fell to a low of \$106.70, then climbed to a high of \$107.55 before closing near the highs at \$107.30. Little activity was seen in the morning session. May outright traded at \$106.95 in 37.5kt. Spreads generally remained unchanged.

When the afternoon session resumed, May/June traded at \$0.7 in 138kt total, and June/July traded at \$0.56 in 100kt. May outright traded in the range of \$106.95 - \$108.10 in 80kt total. May/Aug remained active since yesterday, trading at \$1.75 in 40kt. After DCE closed, May/June traded at \$0.675 in 80kt.

With procurement curbs lifted, inquiries for portside Jimblebar fines have risen, though sellers remain firm due to cost pressures. Primary market liquidity has softened ahead of the holiday, but deals were still done for one cargo each of MACF, BRBF, and NBLU.

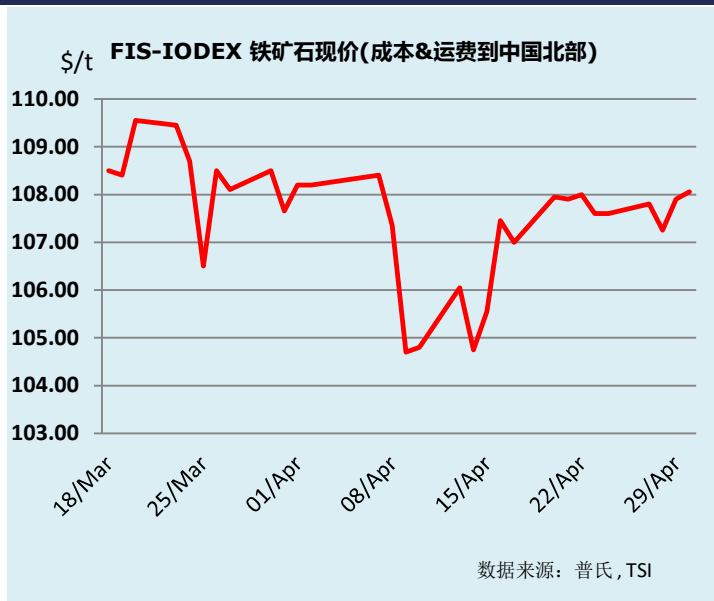

市场评论 / 近期交易

新加坡今早开盘于106.90美元，下跌至106.70美元的低点，随后上涨至107.55美元的高点，最终收于107.30美元，接近当日高点。早盘整体交易清淡。5月在106.95美元交易3.75万吨。价差整体保持不变。

午盘5月/6月在0.70美元总计交易13.8万吨，6月/7月在0.56美元交易10万吨。5月在106.95至108.10美元之间交易8万吨。5月/8月延续昨日活跃，在1.75美元交易4万吨。大商所收盘后，5月/6月在0.675美元交易8万吨。

随着采购限制解除，港口实货金布巴粉矿询盘增加，但由于成本压力，卖家报价依然坚挺。临近假期，初级市场流动性有所降低，但麦克粉、巴西混合粉及纽曼混合块各有一船成交。
