Little activity was seen in this session across both spreads and outright, with spreads also remaining unchanged. Activity was seen in prompt month outright trading in smalls, in a range of 5-10kt.

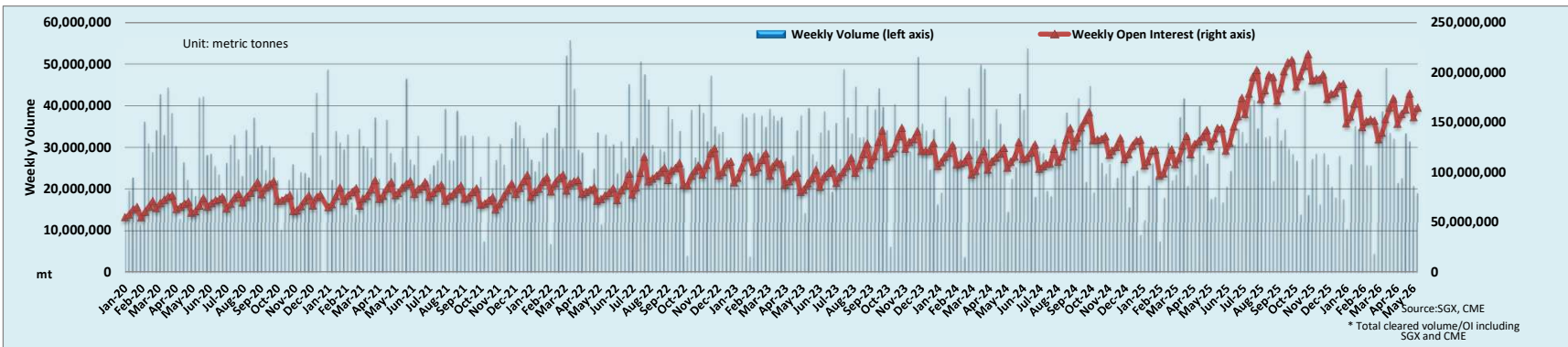
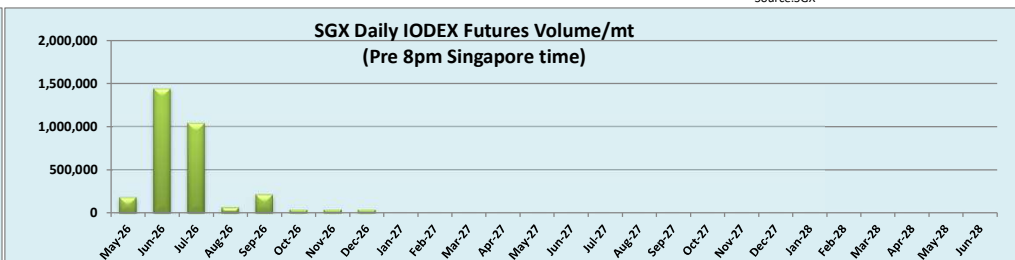
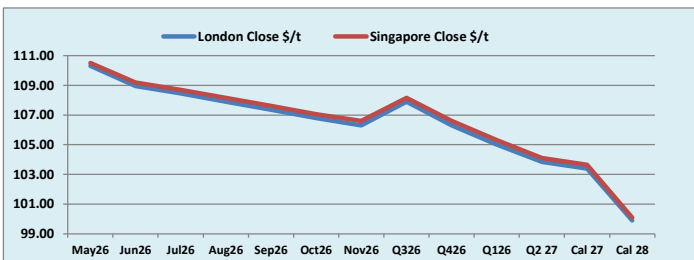
