The London afternoon session opened at \$107.85, which was also the high of the session. Flat price then fell to a low of \$107.55 and closed at \$107.80. Activity in this session was seen in the Jun/July spread, which became softer as we moved into the session. \$0.35 traded in multiple clips totalling 1,100kt. Little liquidity was seen in the session outside of Jun/July, with prompt month outright trading in smalls.

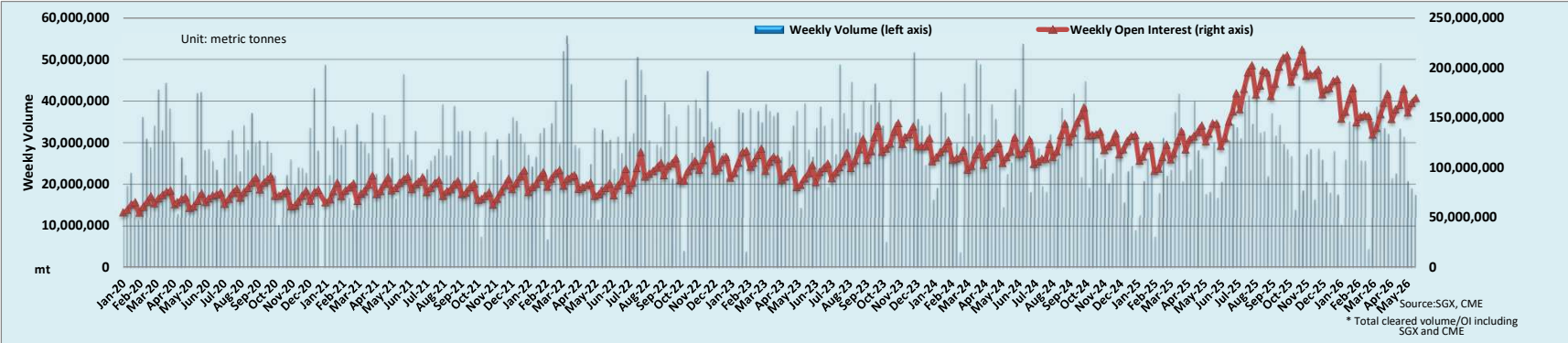
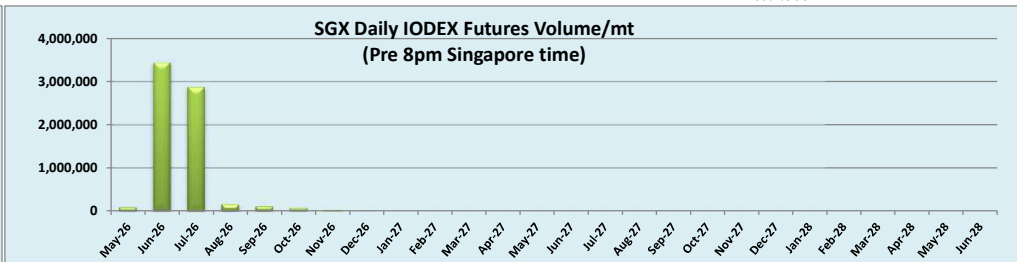
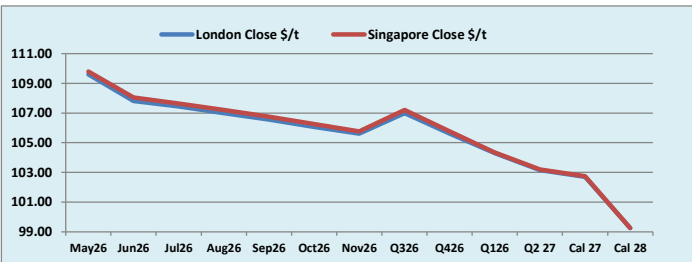
