The London afternoon session opened at \$105.25, which was also the high of the session. Flat price then fell to a low of \$104.75 and closed at \$104.90. Little activity was seen in the session across both outright and spreads. Prompt month outright were seen trading in smalls, except for a clip of Jun in 50kt and Aug in 60kt. Spreads remained unchanged, with Jul/Aug trading at \$0.20 in 54kt.

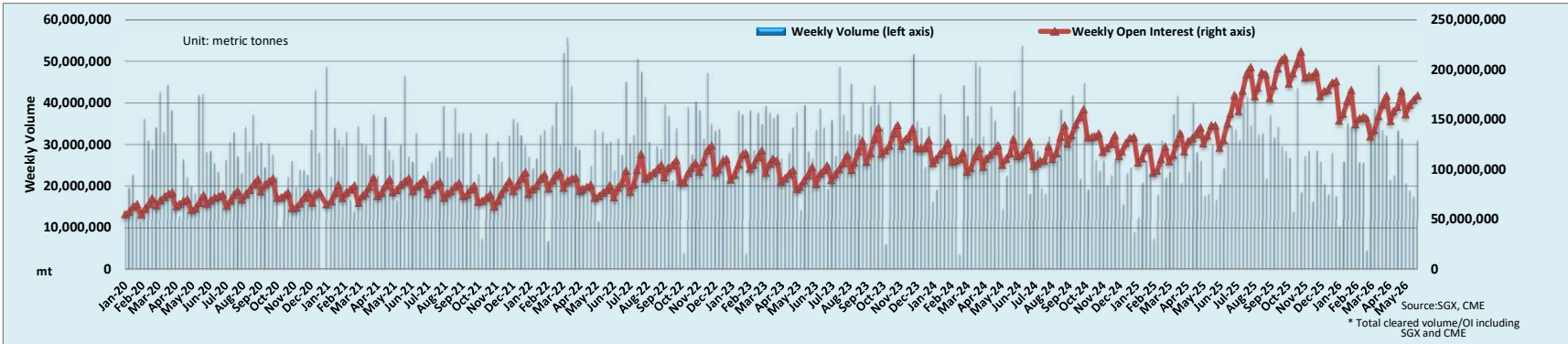
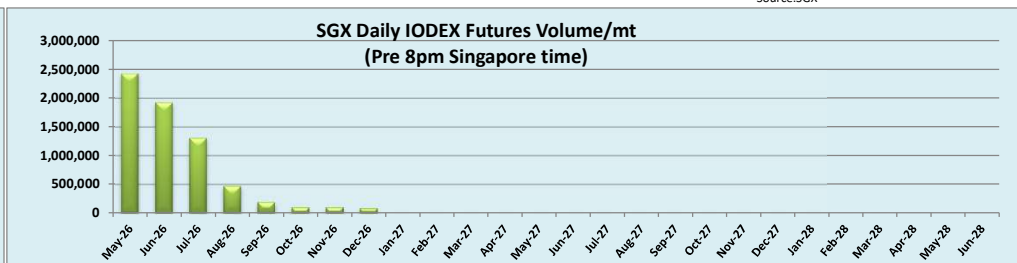
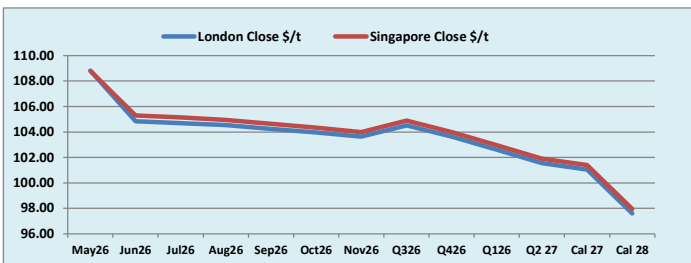
