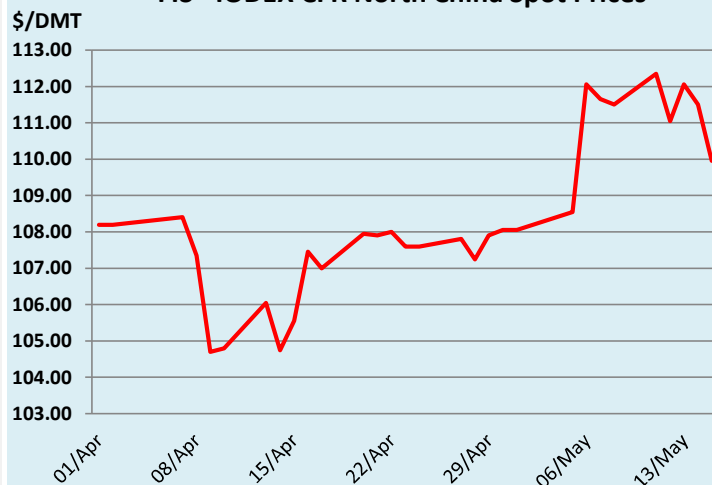
## Market Commentary / Recent Trades

The Singapore morning session opened at \$110.25, went to a high of \$110.45, then fell to a low of \$109.25 before closing near the lows at \$109.45. Little activity was seen in the morning session. Jun outright traded in the range of \$109.40 - \$109.85 in 105kt total. Spreads generally remained unchanged.

When the afternoon session resumed, trading remained muted. Jun/Jul traded at \$0.50 in 50kt. After DCE closed, Q3-26/Q4-26 traded at \$1.55 in 25kt total, and Jun/Sep traded at \$1.60 in 104.4kt. Jun/Jul also traded at \$0.50 again in 30kt total.

Mysteel reported that iron ore inventories at China's 45 ports totaled 165.02 million tonnes, slightly declining by 0.25 million tonnes w/w. Meanwhile, average daily deliveries rose to 3.23 million tonnes, increasing by 247,800 tonnes compared to the previous week.

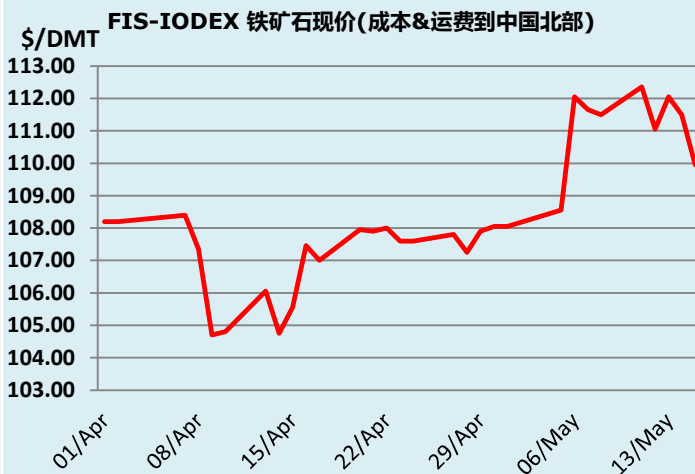

## 市场评论 / 近期交易

新加坡今早开盘于110.25美元，上涨至110.45美元的高点，随后下跌至109.25美元的低点，最终收于109.45美元，接近当日低点。早盘整体交易清淡。6月在109.40至109.85美元之间总计交易10.5万吨。价差基本保持不变。

午盘交易依然清淡。6月/7月在0.50美元交易5万吨。大商所收盘后，26年Q3/26年Q4在1.55美元总计交易2.5万吨，6月/9月在1.60美元交易10.44万吨。6月/7月再次在0.50美元交易3万吨。

我的钢铁网数据显示，中国45个港口铁矿石库存为16502万吨，较上周小幅下降25万吨。同时日均疏港量升至323万吨，周增加24.78万吨。
