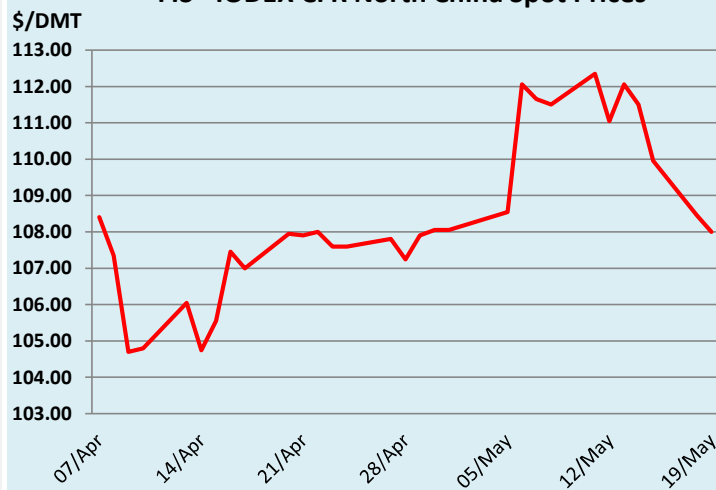
## Market Commentary / Recent Trades

The Singapore morning session opened at a high of \$108.10, then fell to a low of \$107.35 before closing near the lows at \$107.40. Little activity was seen in the morning session. Jul traded in the range of \$107.10 - \$107.45 in 100kt total, and Jun traded at \$107.45 in 50kt total. Front-month spreads were seen narrowing.

When the afternoon session resumed, Oct outright traded at \$105.65 in 65kt. Jun/Jul remained active, trading at \$0.40 in 870kt total. Jul/Aug also started to garner interest as it traded at \$0.45 in 30kt total.

Iron ore arrivals at China's 45 ports totaled 26.99 million tonnes, rising by 4.12 million tonnes week on week. Arrivals at the six northern ports reached 13.17 million tonnes, up 2.53 million tonnes from the previous week.

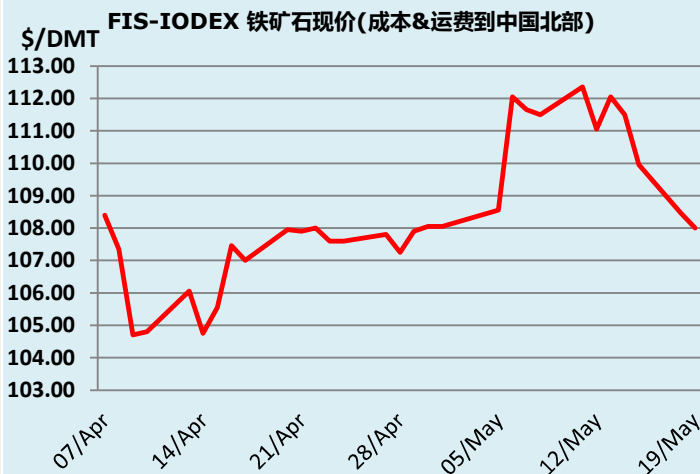

## 市场评论 / 近期交易

新加坡今早开盘于108.10美元的高点，随后下跌至107.35美元的低点，最终收于107.40美元，接近当日低点。早盘整体交易清淡。7月在107.10至107.45美元之间交易10万吨，6月在107.45美元交易5万吨。即期价差整体收窄。

午盘10月在105.65美元交易6.5万吨。6月/7月延续活跃，在0.40美元交易87万吨。7月/8月出现交易兴趣，在0.45美元总计交易3万吨。

中国45个港口铁矿石到港量为2699万吨，周增加412万吨。北方六大港口到港量达到1317万吨，较前一周增加253万吨。
