The London afternoon session opened at \$98.55. Flat price then rose to a high of \$98.85 before falling to a low of \$98.35 and closing at \$98.60. Little activity was seen across both spreads and outright, with trading in prompt months occurring in smalls except for a July clip in 50kt.

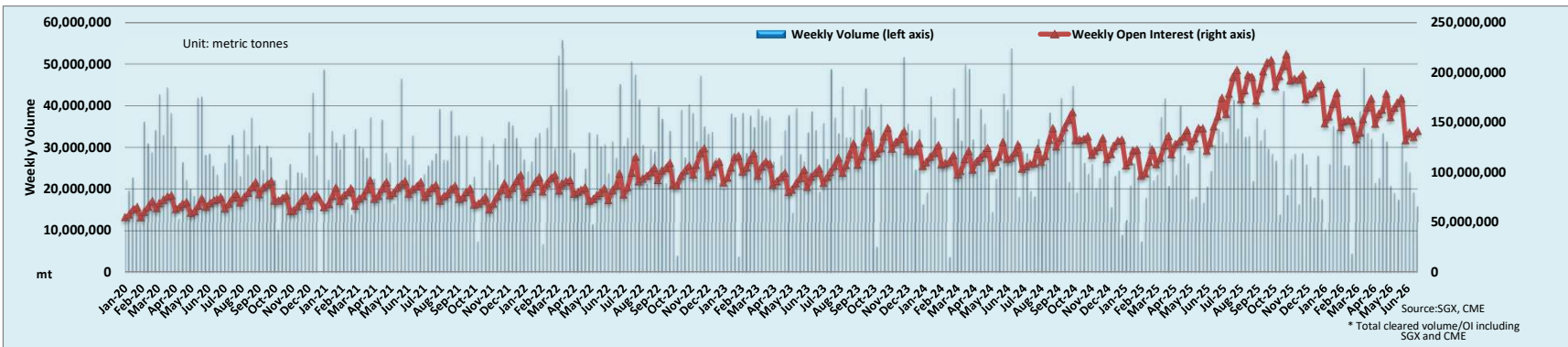
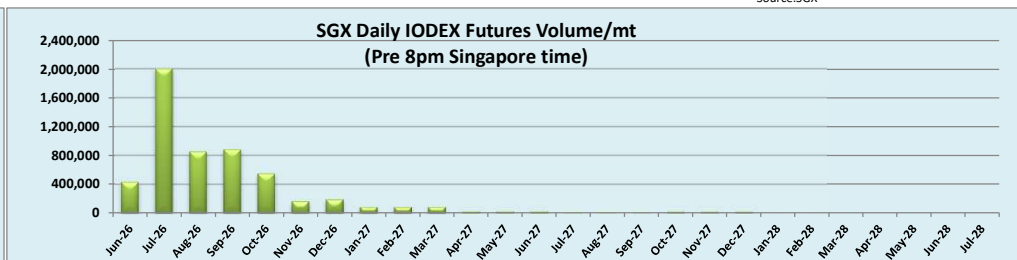
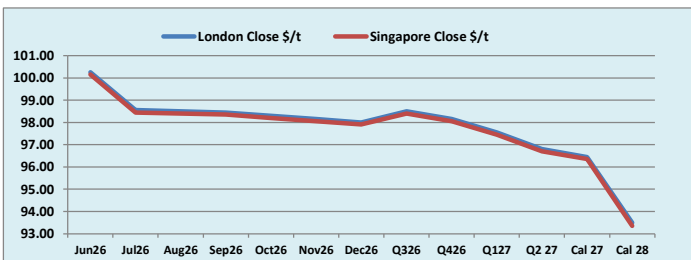
