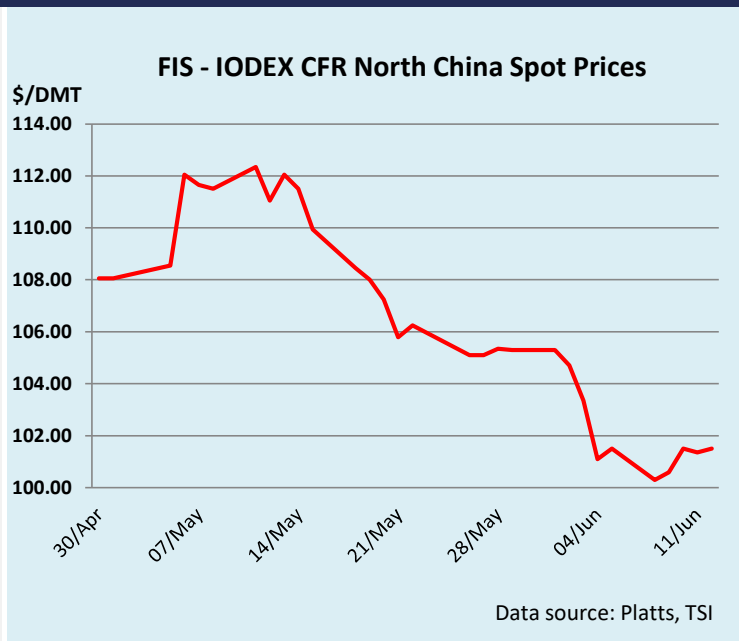

Market Commentary / Recent Trades

The Singapore morning session opened at \$101.70, which was also the high of the session. Flat price then fell to a low of \$101.30 and closed at \$101.55. Little activity was seen in the session across both outright and spreads.

Moving into the afternoon session, muted trading continued to be seen. Spreads remained unchanged during the session; however, some size was seen in outright, with July trading in some sizable clips of 105+105+45+45kt, whilst Cal27 traded in 7kt.

Oil and gas prices fell sharply, with Brent dropping over 4%, as markets grew increasingly optimistic that the US and Iran are nearing a peace deal that could reopen the Strait of Hormuz and ease sanctions on Iranian oil, reducing fears of supply disruptions that had previously driven prices higher.

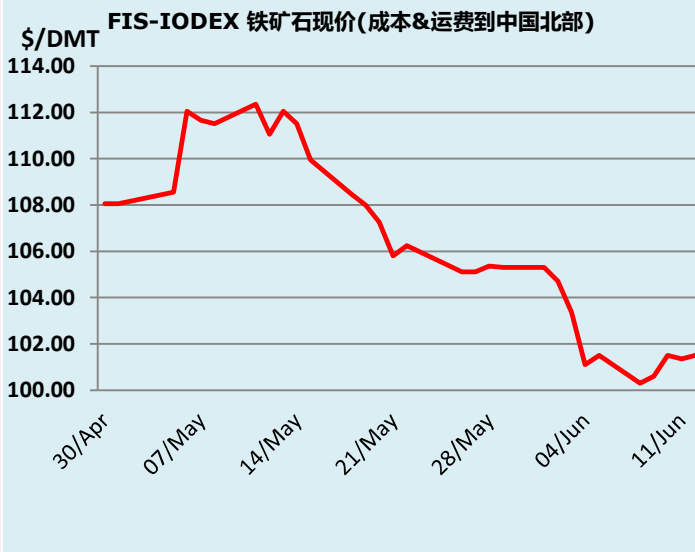

市场评论 / 近期交易

新加坡今早开盘于101.70美元的日内高点。6月随后下跌至101.30美元的最低点，最终收于101.55美元。早盘单月合约和价差合约交易均相对清淡。

午盘市场依然保持安静。价差整体保持不变，不过单月合约有一些交易量，7月分别交易10.5万吨、10.5万吨、4.5万吨及4.5万吨，Cal 27交易7000吨。

油气价格大幅下跌，其中布伦特原油跌幅超过4%。市场情绪乐观，参市者认为美国与伊朗接近达成和平协议，该协议有望推动霍尔木兹海峡重新开放，并缓解对伊朗石油出口的制裁，从而减轻对供应中断担忧，此前供应中断曾推高价格。
