The London afternoon session opened at \$100.40, which was also the high of the session, before flat price fell to a low and close of \$100.05. Little activity was seen in the session across both outright and spreads, with prompt-month outright trading in smalls. Spreads saw little liquidity, except for Q4/Q1 trading at \$0.50 in 88.5kt.

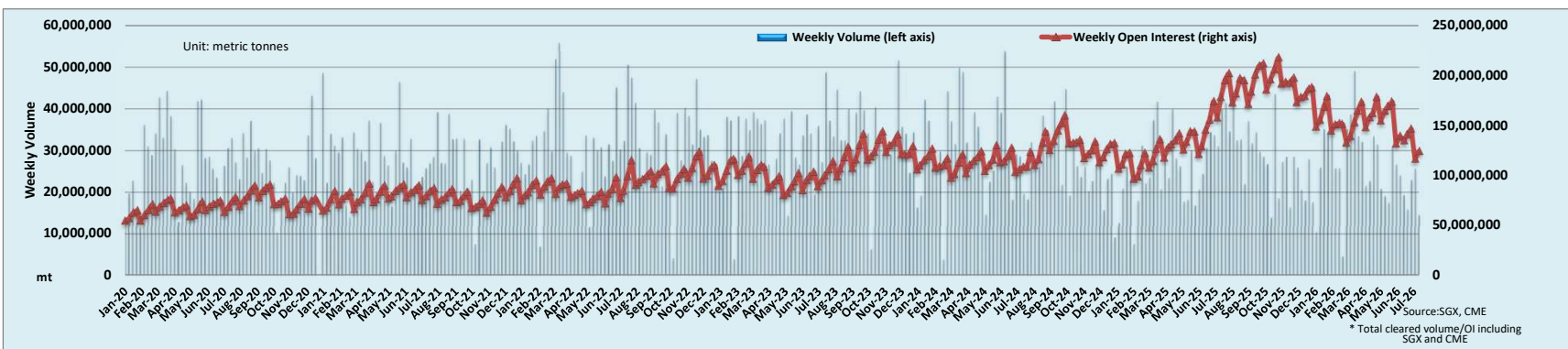
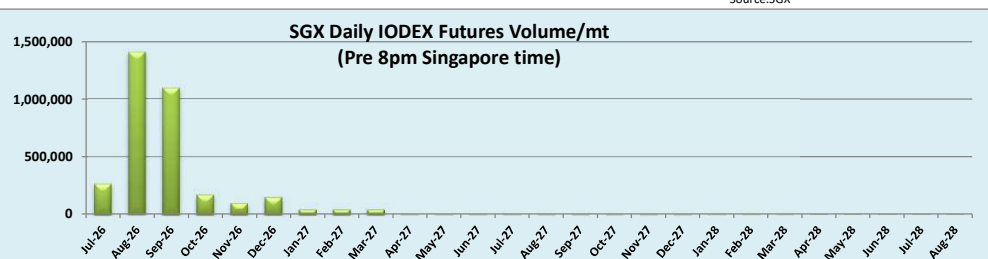
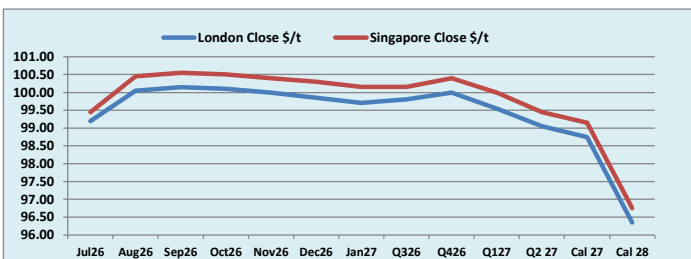
