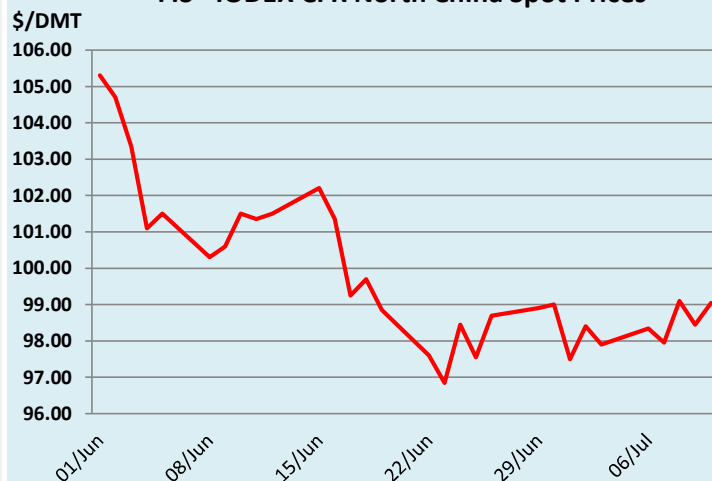

Market Commentary / Recent Trades

The Singapore morning session opened at 98.90, fell to a lows of 98.60 then climbed to highs of 99.60 before closing at 99.30. Little activity was seen in the morning session. Front-month spreads were seen narrowing.

When the afternoon session resumed, trading remained muted. Interest further out were seen as Cal-27/Cal-28 traded 2.25 in 2kt.

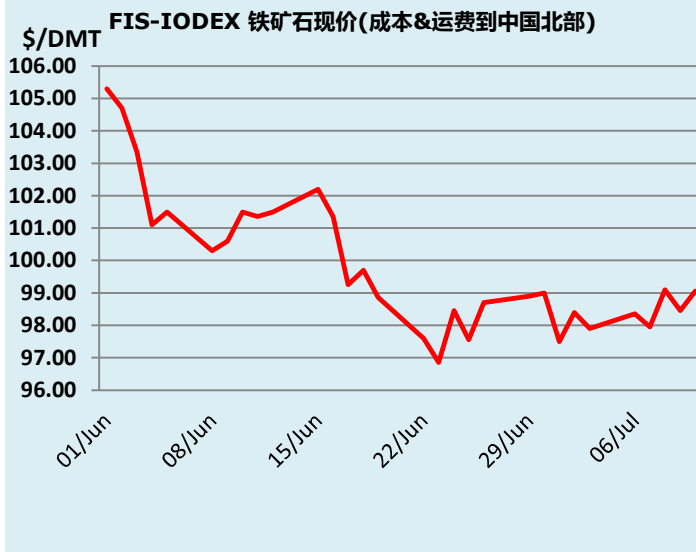
