The London afternoon session opened at \$95.50, before flat price fell to a low of \$94.50, climbed to a high of \$95.80 and closed at \$95.40. Little activity was seen across both outright and spreads. Prompt-month outright traded in smalls, whilst spreads saw little liquidity apart from Aug/Oct trading at -\$0.15 in 155kt and Aug/Sep trading at -\$0.35 in 50kt.

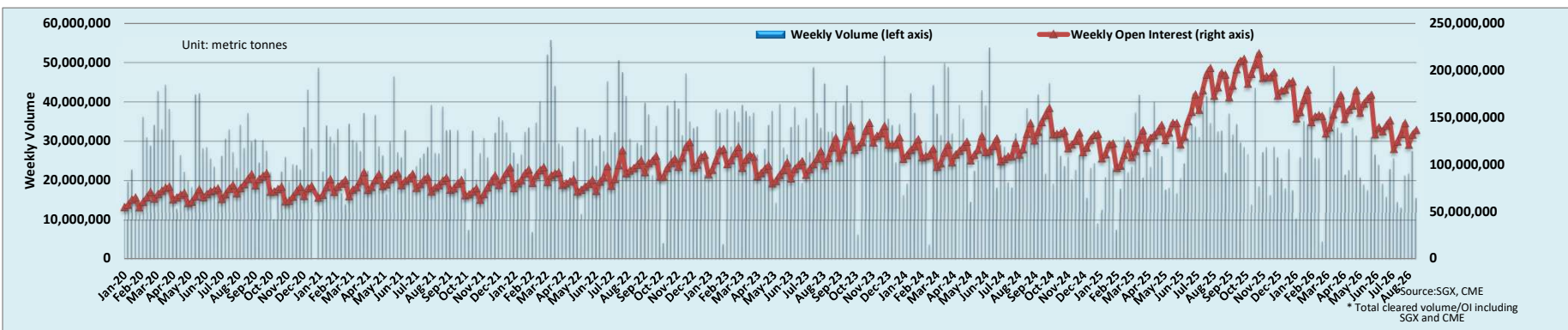
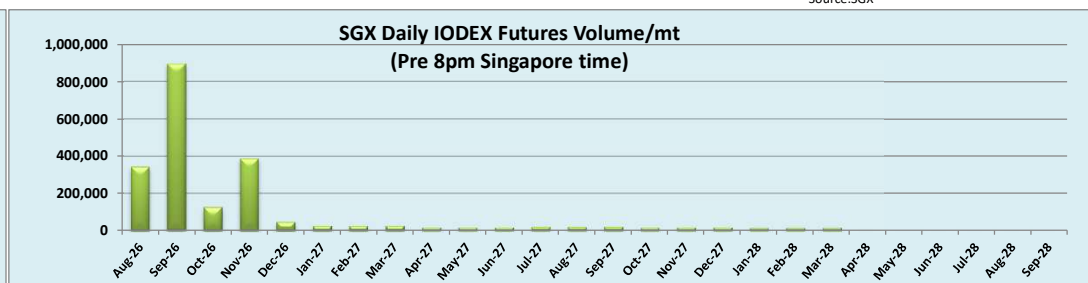
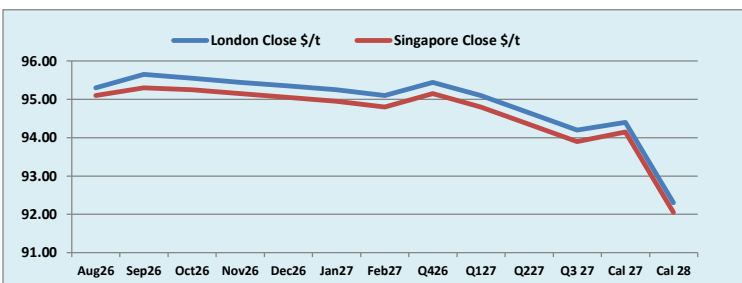
