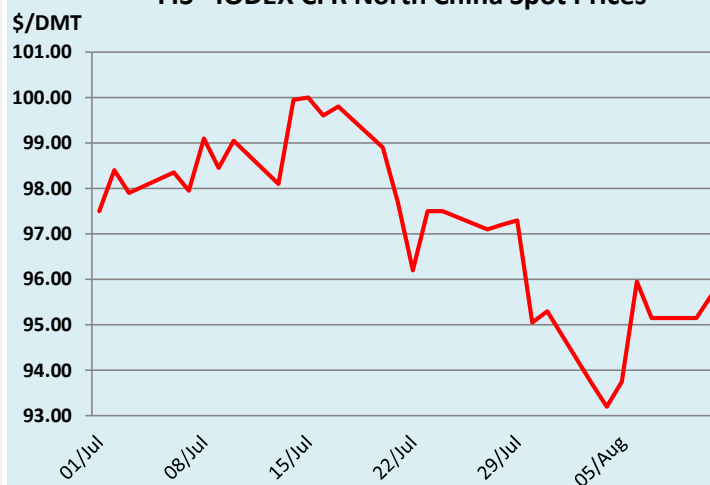
Market Commentary / Recent Trades

The Singapore morning session opened at \$95.20, fell to a low of \$95.00, then climbed to highs of \$96.35 before closing near highs at \$96.00. Little activity was seen in the morning session. Sep/Q4-26 traded at \$0.20 and \$0.25 in 30x10kt each. Q4-26/Q1-27 traded at \$0.35 in 16.8kt total, and Cal-27 traded at \$94.55 in 2kt. Front-month spreads were seen widening.

When the afternoon session resumed, Sep/Q1-27 traded at \$0.55 in 150x50kt and later saw keen selling as it traded at \$0.50 in 30x10kt. Cal-27 then traded at \$94.60 and \$94.70 in 2.5kt each. Sep/Q4-26 remained active since the morning session as it traded at \$0.15 in 30x10kt. After DCE closed, Sep/Oct traded at \$0.05 in 100kt, and Aug/Nov traded at -\$0.20 in 100kt. Interest further out was spotted as Cal-27/Cal-28 traded at \$2.10 in 2.5kt.

During the past week, combined iron ore deliveries from Brazil and Australia fell by 1.69 million tons w/w to 25.69 million tons. Iron ore arrivals at China's 45 major ports also declined sharply by 12.30 million tons to 18.70 million tons, while arrivals at six northern ports dropped by 4.79 million tons to 10.78 million tons, indicating a significant slowdown in seaborne arrivals.

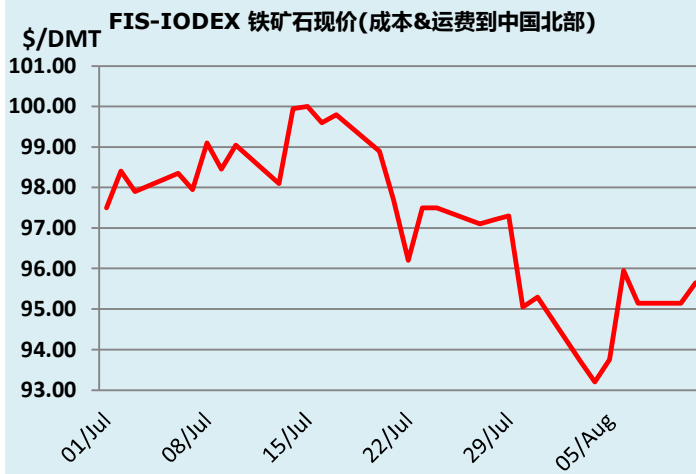

市场评论 / 近期交易

新加坡今早开盘于95.20美元，随后回落至95.00美元的低点，再上涨至96.35美元的高点，收于96.00美元，接近当日高点。早盘相对安静，9月/26年Q4分别在0.20美元和0.25美元交易3×1万吨。26年Q4/27年Q1在0.35美元总计交易1.68万吨，Cal27在94.55美元交易2000吨。即期价差整体呈扩大走势。

午盘9月/27年Q1在0.55美元交易15×5万吨，随后市场出现抛售，价差收窄至0.50美元交易3×1万吨。Cal27随后分别在94.60美元和94.70美元交易2500吨。9月/26年Q4持续活跃，在0.15美元美元交易3×1万吨。大商所收盘后，9月/10月在0.05美元交易10万吨，8月/11月在负0.20美元交易10万吨。远期合约也有一些交易兴趣，Cal27/Cal28在2.10美元交易2500吨。

过去一周巴西和澳大利亚铁矿石总发运量较上周下降169万吨至2569万吨。同时中国45个主要港口铁矿石到港量大幅下降1230万吨至1870万吨，北方六大港口到港量亦下降479万吨至1078万吨，表明近期海运到港量显著放缓。
