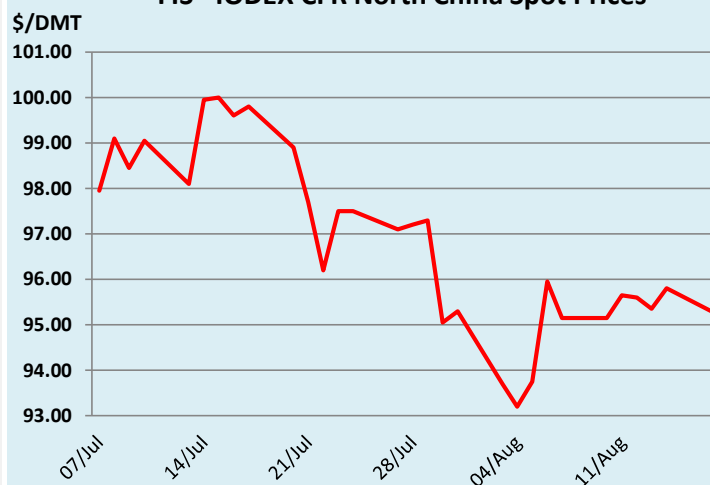
Market Commentary / Recent Trades

The Singapore morning session opened at \$95.95, went to highs of \$96.25, then fell to lows of \$95.50 before closing near lows at \$95.55. Interest further out was spotted as Q4-26/Q1-27 traded at \$0.45 in 7kt, Q1-28 traded at \$93.30 in 5kt, and Cal-27 traded at \$94.25 in 8kt. Spreads generally remained unchanged.

When the afternoon session resumed, Aug spreads remained active as Aug/Nov traded at -\$0.40 in 20kt, then traded at -\$0.25 in 160kt total. Interest further out was spotted again following the morning session as Q1-27 traded in the range of \$94.90 - \$95.00 in 11kt, and Q1-28 traded at \$93.25 in 5kt. After DCE closed, Sep/Nov traded at \$0.15 in 90.5kt.

Blast furnace operations at China's 247 steel mills remained broadly stable last week. The operating rate rose 0.32 percentage points w/w to 82.64%, while blast furnace utilization increased 0.06 percentage points to 89.44%. As a result, average daily hot metal output edged up by 1,700 tonnes to 2.38 million tonnes. However, all three metrics remained lower compared to the same period last year, indicating production levels are still below 2025 levels.

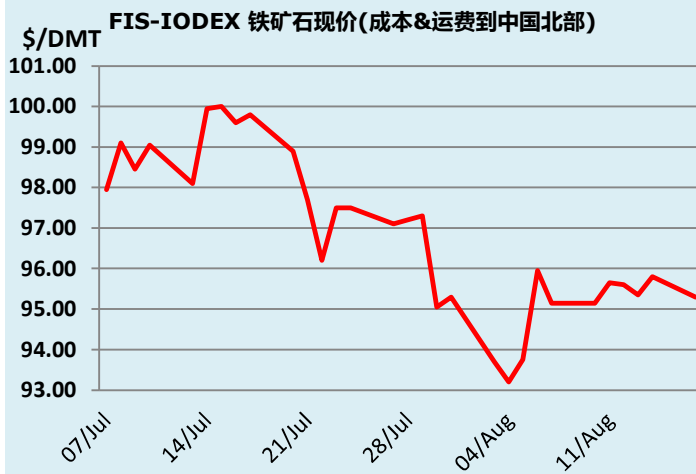

市场评论 / 近期交易

新加坡今早开盘于95.95美元，上涨至96.25美元的高点，随后回落至95.50美元的低点，最终收于95.55美元，接近日内低点。远期合约有不错的市场兴趣，26年Q4/27年Q1在0.45美元交易7000吨，28年Q1在93.30美元交易5000吨，Cal27在94.25美元交易8000吨。价差基本保持不变。

午盘8月相关价差持续活跃。8月/11月先在负0.40美元交易2万吨，随后在负0.25美元总计交易16万吨。远期合约交易兴趣延续至午盘，27年Q1在94.90至95.00美元之间交易1.1万吨，28年Q1在93.25美元交易5000吨。大商所收盘后，9月/11月在0.15美元交易9.05万吨。

上周中国247家钢厂高炉生产整体保持稳定。高炉开工率周上升0.32%至82.64%，产能利用率上升0.06%至89.44%，带动日均铁水产量小幅增加1700吨至238万吨。但上述三项指标均低于去年同期水平，表明当前钢铁生产活动仍低于2025年同期水平。
