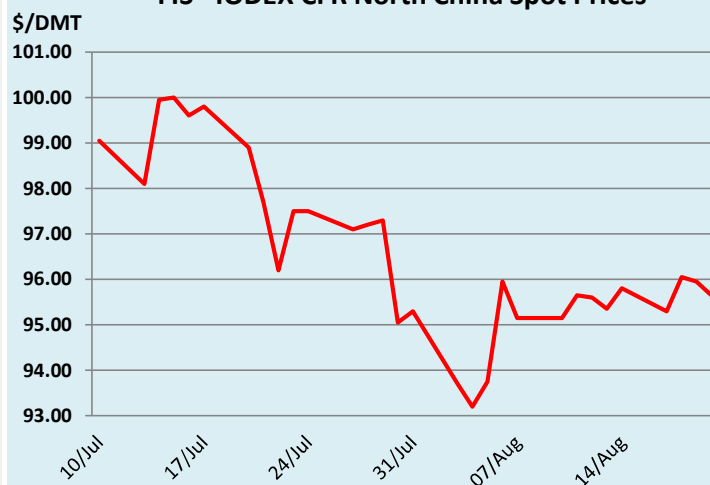
Market Commentary / Recent Trades

The Singapore morning session opened at \$96.00, went to highs of \$96.25, then fell to lows of \$95.05 before closing near lows at \$95.15. Aug spreads remained active since yesterday as Aug/Oct traded at par in 150kt total. Spreads generally remained unchanged.

When the afternoon session resumed, Aug spreads continued to trade as Aug/Oct traded at -\$0.45 in 30kt and Aug/Nov traded at \$0.10 in 40kt. After DCE closed, trading remained muted.

Australia's iron ore supply remains robust, with exports rising 4.4% year-on-year to 468.1 million tons in the first half as new production capacity continues to ramp up. Major producers, including BHP, Rio Tinto, and Fortescue, have maintained or increased shipment guidance, supported by capacity expansions and strong operational performance. Rio Tinto's Pilbara output reached its highest first-half level since 2018, while Mineral Resources' Onslow project achieved a 38 million-ton annualized run rate, and Fortescue's Iron Bridge shipped 6.8 million tons in 1H.

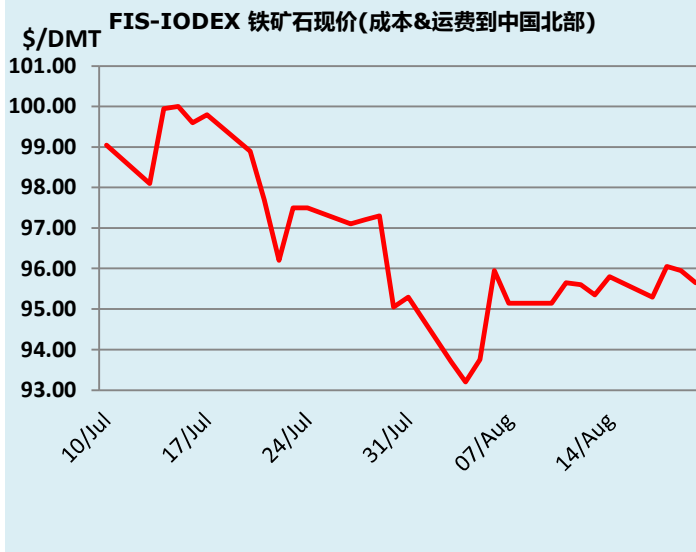

市场评论 / 近期交易

新加坡今早开盘于96.00美元，上涨至96.25美元的高点，随后回落至95.05美元的低点，收于95.15美元，接近日内低点。8月相关价差保持活跃，8月/10月价格持平总计交易15万吨。价差基本保持不变。

午盘8月相关价差持续成交，8月/10月在负0.45美元交易3万吨，8月/11月在0.10美元交易4万吨。大商所收盘后，市场依然安静。

澳大利亚铁矿石供应强劲。随着新增产能持续释放，今年上半年铁矿石出口量年增长4.4%至4.681亿吨。由于产能扩张及良好的运营表现为供应增长提供支撑，必和必拓、力拓及FMG等主要矿商均保持或上调发运量。其中力拓皮尔巴拉矿上半年产量达到2018年以来同期最高水平，澳洲矿产资源公司的昆斯洛铁矿项目年化产量已达到3800万吨，FMG的铁桥项目上半年发运680万吨。
